- Good afternoon Fowler Family!
- COVID UPDATE:
 - Yesterday Dallas County reported 1110 new cases from Friday
 - Dallas County continues to experience high hospitalization rate primarily among those who are unvaccinated
 - Last Friday, the DFW hospital council reported that for the 2nd time in in August, there were no pediatric ICU beds left in North Texas
 - Fowler will continue to educate and support the efforts to vaccinate all those who are eligible so that together we can protect our children who are not eligible for vaccines
 - o As a community, we each have an obligation to protect others by getting vaccinated
 - One of our health partners shared these COVID vaccine facts:
 - 357 million doses of COVID19 vaccine have been given in the United States between December 14 and August 16, 2021
 - The COVID-19 vaccines are safe and effective. They were evaluated in tens of thousands of participants in clinical trials
 - The COVID 19 vaccines are not experimental. They went through all the required stages of clinical trials
 - The vaccines met the Food and Drug Administrations rigorous scientific standards for safety, effectiveness and manufacturing quality needed to support emergency use authorization
 - COVID 19 vaccines help keep you from getting seriously ill in the event you do get COVID 19 – they help prevent death.
 - None of the COVID19 vaccines contain the live virus that cause COVID 19 so a COVID 19 vaccine cannot make you sick with COVID
 - Get vaccinated regardless of whether you already had COVID. Evidence is emerging that people get better protection by being fully vaccinated compared with having had COVID 19. One study showed that unvaccinated people who already had COVID 19 are more than 2 times as likely than fully vaccinated people to get COVID 19 again!

• FOWLER UPDATES:

- The Fowler team continues to have some of the highest vaccine rates in the healthcare industry.
- We continue to move towards our goal of 100% vaccination status for team and urge all residents and family members to be vaccinated

- Since day we made the decision to close the Fowler campus last March 11, 2020, we have provided information, updated policies and revised conditions for employment
 - We have all been making choices team member, residents, and family members
 - Our team members have made choices to accept conditions of employment and will continue to do so
 - We have a mask mandate in place at Fowler that applies to every team member – that is a condition of employment
 - We have a vaccine mandate in place at Fowler that applies to every team member – that is a condition of employment
 - When you choose not to wear the required mask type, or choose not to wear it the right way, or when you choose not to vaccinate, you are choosing to resign
- This is about decisions we make decisions in the best interest for all those who live and work at Fowler; team members have the choice to accept the decisions of employment
- We want to clarify
 - Our mask stance is that all team members who are not fully vaccinated must wear an N95 mask or KN95 mask
 - If you enter a licensed area, you must wear an N95 mask or KN95 regardless of vaccination status
 - Fully vaccinated status = 2 weeks after second dose in a 2-dose series, such as the Pfizer of Moderna vaccines or 2 weeks after a single-dose vaccine such as Johnson's vaccine.
 - TO meet the condition of employment regarding vaccines, the following schedule should be followed:
 - 1st shot must be secured by:
 - If Moderna, by 9/3
 - o If Pfizer, by 9/10
 - 2nd shot must be secured by: by 10/1
 - If Johnson & Johnson single shot, by 10/1
- We have had some theft of landscaping equipment
 - They are doing it in broad daylight!
 - Keep your eyes open for individuals you do not recognize and shouldn't be here
 - If you see someone walking through the community with a weed eater and they do not have on a Fowler maintenance uniform or the Yard Guys uniform, chances are they aren't doing yard work
 - While cars have not been the target to date, do not leave valuables in your car
- Lisa Mumford, Director of Ebby House has been nominated for the George Washington

In the month of August, we recognized "Women's Equality Day"

- Women's Equality Day is celebrated in the United States on August 26 to commemorate the 1920 adoption of the Nineteenth Amendment to the United States Constitution, which prohibits the states and the federal government from denying the right to vote to citizens of the United States based on sex.
- It was first celebrated in 1971, designated by Congress in 1973, and is proclaimed each year by the United States President.

- In 1971, following the 1970 nationwide Women's Strike for Equality, and again in 1973, as the battles over the Equal Rights Amendment continued, Congresswoman Bella Abzug of New York introduced a resolution to designate August 26 as Women's Equality Day.
- In 1972, President Richard Nixon issued Proclamation 4147, which designated August 26, 1972, as "Women's Rights Day" and was the first official proclamation of Women's Equality Day.
- On August 16, 1973, Congress approved H.J. Res. 52, which stated that August 26 would be designated as Women's Equality Day and that "the President is authorized and requested to issue a proclamation in commemoration of that day in 1920 on which the women in America were first guaranteed the right to vote". The same day, President Nixon issued Proclamation 4236 for Women's Equality Day, which began, in part: "The struggle for women's suffrage."
- In recent years, we have made other giant strides by confronting sex discrimination through our laws and by paving new avenues to equal economic opportunity for women. Today, in virtually every sector of our society, women are making important contributions to the quality of American life.
